

## More School Shootings: U.S. Frequencies Prove Deadly

Today the internet and news agencies are abuzz with news of yet another school shooting with at least three students in Lancaster, Pa. already reported dead at the hands of a milk truck driver and more details will emerge later. This shooting follows several school shootings from last week in which a school principal was killed, and a 16 year old Colorado student was also killed, and the U.S. Law enforcement-media system is offering no real explanation as to why these outbreaks of extreme violence keep recurring. ### Shooting of Denver-Aurora Officer Thomas has Gag Order
